**EMERGENCY PROCEDURES**
**24 HOUR ADVICE IN AN EMERGENCY ONLY: 0800 844 455**

IF THIS HAPPENS	DO THIS
<b>Tanker/Vehicle Accident</b>	Switch off engine and electrical equipment. Keep people away, warn other traffic. Check for spills, leaks. <b>Call the emergency services: Dial 111</b>
<b>Spill or leak</b>	Isolate area. DO NOT touch or walk through spilled material. Spilled material may cause a slipping hazard. Ventilate area and keep upwind of spill. Wear faceshield or goggles, chemical resistant overalls (buttoned to neck and wrist), gloves and boots. Stop leak if safe to do so. Dike area and prevent entry into waterways and drains. <b>Small spills/leaks:</b> Sweep up spilled product and place into sealable, properly labelled container for disposal. Seek advice from the SDS, product label or Corteva Agriscience regarding disposal. <b>Large spills/leaks:</b> Report large spills to Corteva Agriscience Emergency Services at 0800 844 455.
<b>Fire</b>	<b>Call the Fire Service: Dial 111.</b> Fumes and combustion products produced in a fire may be toxic and/or irritating. Processing this product may generate dust. Dust explosion hazard may result from forceful application of fire extinguishing agents. Wear positive pressure self-contained breathing apparatus (SCBA) and protective fire fighting clothing. <b>Small fire:</b> Use water fog or fine spray, dry chemical, CO <sub>2</sub> or foam. <b>Large fire:</b> Use foam or water. If safe to do so, move undamaged containers from fire area. Deny unnecessary entry. Do not allow material or run-off to enter waterways.

**FIRST AID**

<b>If Swallowed:</b>	No specific antidote. Call the National Poisons Information Centre (0800 POISON; 0800 764 766) or doctor for treatment advice. Do not induce vomiting unless told to do so by Poisons Information Centre or doctor. Do not give anything by mouth to an unconscious person.
<b>If in Eyes:</b>	Hold eyes open and rinse slowly and gently with water for 15 – 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Call a poison control centre or doctor for treatment advice. Suitable emergency eye wash facility should be available.
<b>If on Skin:</b>	Remove contaminated clothing. Rinse skin immediately with plenty of water for 15 – 20 minutes. Call a poison control centre or doctor for treatment advice. Wash clothing before re-use.
<b>If Inhaled:</b>	Move person to fresh air. If person is not breathing, call an emergency responder or ambulance, then give artificial respiration; if by mouth-to-mouth use rescuer protection (pocket mask etc). Call the Poison Information Centre or doctor for treatment advice.

**STORAGE AND SEGREGATION**

**Storage:** Store in tightly closed original container in a cool, dry well-ventilated area out of direct sunlight when not in use. This product can be stored in an unheated building. Do not store with food, feedstuffs, fertilizers and seeds. See product label for further handling/storage precautions relative to the end use of this product.
